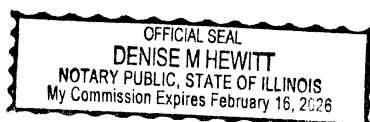

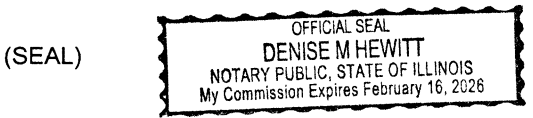

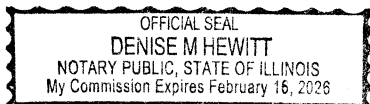

THEREFORE:


- (1) I will conduct my campaign openly and publicly, and limit attacks on my opponent to legitimate challenges to his record.

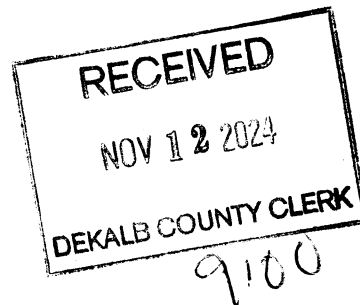
